There was a motion by Lisa Stortzum and a second by Kristin Morrissey to increase Materials expenses and decrease Operations expenses by \$5,000.00 to cover the replacement of materials damaged at Sharon Forks. Motion carried unanimously, with all Board members present.

There was a motion by Mary Helen McGruder and a second by Kristin Morrissey to approve the Library's revised Calendar year 2023 County funding request as presented. Motion carried unanimously, with all Board members present.
