There was a motion by Christy Winters and a second by Kathy Thomas to reduce Donations revenue and Operations expenses by \$1,100.00 to reflect the funds to be distributed in FY2023 for the Community Webs Grant. Motion carried unanimously, with all Board members present.

There was a motion by Lisa Stortzum and a second by Kristin Morrissey to reduce Federal revenue and Operations expenses by \$2,111.10 to reflect the difference in the amount to be reimbursed for the Emergency Connectivity Funds grant. Motion carried unanimously, with all Board members present.
