The Board voted unanimously to approve FCPL's Fiscal Year 2024 proposed budget as presented, including revenues of \$8,873,412, expenditures of \$9,119,258, reserves of \$273,600, and \$519,446 in budgetary fund balance.

7. Calendar Year 2024 County budget request

The Board voted unanimously to approve the Library's Calendar Year 2024 County funding request as presented and to grant Anna Lyle the authority to adjust amounts based on changes to the projected opening day of the Denmark Library.
